- 3) ENROLL BY 05/18/2018 AND SUCCESSFULLY COMPLETE, AT YOUR EXPENSE, THE ELECTRONIC MONITORING PROGRAM (ANKLE BRACELET) THROUGH LCA CLIENT SERVICES.
- 4) PAY FEE OF \$500.00 TO THE DOMESTIC VIOLENCE FUND (PC 1203.097(A)(5)).
PAY VICTIM RESTITUTION. AMOUNT TO BE DETERMINED BY THE PROBATION DEPARTMENT (PC 1203.1(A)(3)). ANY DISPUTES AS TO RESTITUTION AMOUNT TO BE RESOLVED IN A COURT HEARING.
- 6) PROBATION OFFICER OR LAW ENFORCEMENT OFFICER; WITH OR WITHOUT CAUSE; SUBMIT TO IMMEDIATE SEARCH/PROPERTY INCLUDING ALL RESIDENCE/PREMISES/STORAGE UNITS, CONTAINERS AND VEHICLES UNDER YOUR CONTROL; BY SEARCH FOR THE DETECTION OF FIREARMS.
ENROLL IN A PROBATION APPROVED 52-WEEK DOMESTIC VIOLENCE PROGRAM PURSUANT TO PC 1203.097. PROVIDE PROOF OF ENROLLMENT TO THE COURT/PROBATION OFFICER ON OR BEFORE 00/00/0000. COMPLETE THE PROGRAM BY 07/02/2019. PAY ALL PROGRAM FEES AND SUBMIT PROOF OF PAYMENT AND COMPLETION AS DIRECTED BY PROBATION.
- 7) DO NOT LEAVE THE STATE OF CALIFORNIA WITHOUT FIRST OBTAINING WRITTEN PERMISSION OF THE PROBATION DEPARTMENT PER THE INTERSTATE COMPACT ACT.
- 8) DO NOT ANNOY, HARASS, THREATEN, OR DISTURB THE PEACE OF
- 9) DO NOT KNOWINGLY OWN, POSSESS, HAVE UNDER YOUR CONTROL OR IMMEDIATE ACCESS
