23 INTRODUCTION

24 "The prosecuting attorney shall be given a two day written notice and an opportunity to be  
25 heard . . . except that, as to modify(ing) or terminating a protective order in a case involving  
26 domestic violence... the prosecuting attorney shall be given a five-day written notice and an  
27 opportunity to be heard." (Pen. Code, § 1203.3, subd. (b)(1).) "Relief shall not be granted under  
28 this section unless the prosecuting attorney has been given 15 days' notice of the petition for  
29 relief. The probation officer shall notify the prosecuting attorney when a petition is filed,  
30 pursuant to this section." (Pen. Code, § 1203.4, subd. (e)(1).)
