SUMMARY PROBATION GRANTED FOR A PERIOD OF 36 MONTHS ON THE FOLLOWING TERMS AND CONDITIONS.

- 1) OBEY ALL LAWS, ORDINANCES, AND COURT ORDERS.
- 2) BE COMMITTED TO THE CUSTODY OF THE RIVERSIDE COUNTY SHERIFF FOR 90 DAYS;
- 3) 89 DAYS TO BE SERVED IN THE WORK RELEASE PROGRAM. REPORT ON OR BEFORE 10/28/2022.
- 4) PAY FEE OF \$500.00 TO THE DOMESTIC VIOLENCE FUND (PC 1203.097(A)(5)).
- 5) ENROLL IN A PROBATION APPROVED 52-WEEK DOMESTIC VIOLENCE PROGRAM PURSUANT TO PC 1203.097. PROVIDE PROOF OF ENROLLMENT TO THE COURT/PROBATION OFFICER ON OR BEFORE 10/11/2022. COMPLETE THE PROGRAM BY 10/11/2023. PAY ALL PROGRAM FEES AND SUBMIT PROOF OF PAYMENT AND COMPLETION AS DIRECTED BY PROBATION.
- 6) DO NOT LEAVE THE STATE OF CALIFORNIA WITHOUT FIRST OBTAINING WRITTEN PERMISSION OF THE PROBATION DEPARTMENT PER THE INTERSTATE COMPACT ACT.
- 7) DO NOT RELOCATE FROM THE STATE OF CALIFORNIA (I.E. REMAIN IN ANOTHER STATE FOR MORE THAN 45 CONSECUTIVE DAYS IN ANY 12-MONTH PERIOD) -WITHOUT FIRST CONTACTING THE PROBATION DEPARTMENT TO DETERMINE WHETHER YOU ARE SUBJECT TO THE INTERSTATE COMPACT ACT. (ICAOS/PC 11180).
- 8) DO NOT ANNOY, HARASS, THREATEN, OR DISTURB THE PEACE OF I
- 9) PERFORM 20 HOURS OF COMMUNITY SERVICE THROUGH ALTERNATIVE SENTENCING PROGRAM. FILE PROOF OF COMPLETION BY 10/11/2023. REPORT TO THE ALTERNATIVE SENTENCING PROGRAM WITHIN 14 DAYS FROM TODAY OR 14 DAYS FROM RELEASE FROM CUSTODY.
