- 1) OBEY ALL LAWS, ORDINANCES, AND COURT ORDERS.
- 2) BE COMMITTED TO THE CUSTODY OF THE RIVERSIDE COUNTY SHERIFF FOR 1 DAYS;
- 3) BE COMMITTED TO THE CUSTODY OF THE RIVERSIDE COUNTY SHERIFF FOR ONE DAY FOR BOOKING PURPOSES ONLY. REPORT TO NEAREST RIVERSIDE COUNTY JAIL BY 11/21/2023
- 4) PAY A FINE AND PENALTY ASSESSMENT OF \$609.00.
- 5) PAY VICTIM RESTITUTION. AMOUNT TO BE DETERMINED BY THE PROBATION DEPARTMENT (PC 1203.1(A)(3)). ANY DISPUTES AS TO RESTITUTION AMOUNT TO BE RESOLVED IN A COURT HEARING.
- 6) DO NOT DRIVE WITH ANY MEASURABLE AMOUNT OF ALCOHOL OR DRUGS IN YOUR BLOOD, OR WITHIN 6 HOURS OF CONSUMING ANY ALCOHOL OR DRUGS.
- 7) IF ARRESTED FOR DRIVING UNDER THE INFLUENCE OF INTOXICANTS, SUBMIT TO ANY BLOOD, BREATH, OR URINE TEST AS REQUESTED BY THE ARRESTING OFFICER.
- 8) DO NOT DRIVE UNLESS PROPERLY LICENSED NOR WITHOUT INSURANCE OR VALID REGISTRATION.
- 9) ATTEND AND SATISFACTORILY COMPLETE 12 HOUR ALCOHOL AND DRUG EDUCATION SESSION OF DUI PROGRAM (WET RECKLESS SB1176<.08BAC)
- 10) DO NOT RELOCATE FROM THE STATE OF CALIFORNIA (I.E. REMAIN IN ANOTHER STATE FOR MORE THAN 45 CONSECUTIVE DAYS IN ANY 12-MONTH PERIOD) -WITHOUT FIRST CONTACTING THE PROBATION DEPARTMENT TO DETERMINE WHETHER YOU ARE SUBJECT TO THE INTERSTATE COMPACT ACT. (ICAOS/PC 11180).
